- The city is working on a separate study for the Stonestreet corridor, due in the Feb-March timeframe as a first draft. LPCA is encouraged to provide feedback. - WINX update: The county extended to Dec 31st the option to purchase the property. This will determine the next step for the city and our neighborhood
