On behalf of Toll Mid-Atlantic LB Company Inc. (the "Applicant"), we cordially invite you to attend a Pre-Application Area Meeting to be held on June 24, 2025, at 6:30 p.m., for the proposed redevelopment of the properties located at 1600 Research Blvd., 1700 Research Blvd., and 1441 W. Montgomery Ave., in Rockville. The Applicant intends to submit an Application for a Pre-Application Meeting (the "PAM") to the City of Rockville in the near future prior to submitting a Level 2 Site Plan Application that will request approval to redevelop the Property with 131 townhouses and 74 two-over-two residential units. Commencement of construction is currently estimated to occur early in 2028.
